**Agenda item No. 1**

The Executive Committee noted the Minutes of last meeting held on 05.04.2019 and asked the office to provide the details of action taken in next meeting.

**Agenda item No.3**

**Ministry's letter No.C.29012/01/2018-EP(IM-2) dated 06th March, 2019 regarding Legal fee to the advocates hired by CCH.**

The Executive Committee considered the details of all the pending legal cases which have been received before & after constitution of BoG where payment of the advocates are pending. Committee discussed the matter in light of the Ministry's letter dated 06.03.2019 along with O.M. dated 01.10.2015 of Dept. of Legal Affairs as well as payments made by CCIM to its advocates and decided that the legal fee so fixed by the Council (per hearing/lump sum) prior to 08.06.2018, be paid to respective advocate. In the light of the decision taken by the BoG in its meeting held on 08.06.2018, the Executive Committee after considering the experience of the advocates engaged by the Council from time to time, further decided to restrict the legal fee of the all the Councils advocates w.e.f. 08.06.2018, to the fee fixed by the Dept. of Legal Affairs, Ministry of Law vide its O.M. dated 01.10.2015 under its table (B) for the Senior Central Govt. Standing Counsels.

So far as meaning of effective and non effective hearings is concerned, Committee asked Shri S.N. Tripathi, Legal Consultant to go to Ministry of Law to seek clarification in the matter.

All new cases may be assigned only to Govt. panel advocates and where there is no Govt. panel advocate, Council's Retainer Advocate may be deputed.

#### **Agenda item No.4**

**A letter dated 05.04.2019 has been received from Ministry of AYUSH regarding guidelines of admission of students with “Special Disabilities” under the Rights of Persons with Disabilities Act, 2016 and time schedule of counselling with respect of admission in ASU&H UG course, of Homoeopathy.**

The Executive Committee considered the letter of Ministry of AYUSH dated 05.04.2019 regarding amendments in relevant Regulations with respect to “specific disabilities” in the light of “Right of Persons with Disabilities Act, 2016” & time schedule of counselling and agreed in principle to amend the same.

Further, the Executive Committee also considered the time schedule of counselling prepared with consultation to CCIM for completion of the admission process for ASU&H courses which is to be notified in relevant UG Regulations.

**Agenda item No.3**

**Ministry's letter No.C.29012/01/2018-EP(IM-2) dated 06th March, 2019 regarding Legal fee to the advocates hired by CCH.**

The Executive Committee considered the details of all the pending legal cases which have been received before & after constitution of BoG where payment of the advocates are pending. Committee discussed the matter in light of the Ministry's letter dated 06.03.2019 along with O.M. dated 01.10.2015 of Dept. of Legal Affairs as well as payments made by CCIM to its advocates and decided that the legal fee so fixed by the Council (per hearing/lump sum) prior to 08.06.2018, be paid to respective advocate. In the light of the decision taken by the BoG in its meeting held on 08.06.2018, the Executive Committee after considering the experience of the advocates engaged by the Council from time to time, further decided to restrict the legal fee of the all the Councils advocates w.e.f. 08.06.2018, to the fee fixed by the Dept. of Legal Affairs, Ministry of Law vide its O.M. dated 01.10.2015 under its table (B) for the Senior Central Govt. Standing Counsels.

So far as meaning of effective and non effective hearings is concerned, Committee asked Shri S.N. Tripathi, Legal Consultant to go to Ministry of Law to seek clarification in the matter.

All new cases may be assigned only to Govt. panel advocates and where there is no Govt. panel advocate, Council's Retainer Advocate may be deputed.
