The Executive Committee discussed the matter regarding non submission of the required documents sought from the college and took note of mail dated 22.05.2019 (wherein college has submitted that they have sent required documents through speed post) and decided to defer the matter for next meeting i.e. 27.05.2019.

## Agenda Item No.8.1

Order dated 09.05.2019 of Hon'ble High Court of Delhi at New Delhi in W.P.(C) No.2829/2019 in respect of Rishiraj Singh Memorial Society, Habibganj Station, Bhopal(M.P.) for Opening of New H.M.C. in the name of "Narayan Shree Homoeopathic Medical College, Hospital and Research Centre, Indore(M.P.).

The Executive Committee discussed the Order dated 09.05.2019 of Hon'ble High Court of Delhi at New Delhi in W.P.(C) No.2829/2019 and agreed to process the application as per Establishment of New Homoeopathy Medical College, (Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College) Regulations and directed the office to call all deficient documents from the college and place before committee in next meeting.

#### Agenda Item No.8.2

A letter dated 24.04.2019 has been received from Ministry of AYUSH regarding VIP representation dated 10.04.2019 received from Secretary to the Vice-President of India in respect of MF (Hom) qualification.

The Executive Committee discussed the matter threadbare in respect of MF (Hom) qualification received through Medwin Hospital, Hyderabad and noted that MF (Hom), UK degree is the historical legacy which is continuing till date. There has been no unanimity between CCH and MCI or for that matter, between CCIM & MCI regarding graduates of each other disciplines (i.e. BHMS/MBBS) being allowed to practice

(perhaps to a prescribed extent) the other discipline after undergoing a bridge course in respect of the concerned other discipline. Effort was initiated by Ministry of Health & Family Welfare and the Dept. (later Ministry) of AYUSH, Government of India, in that regard in 2013-14. The then Council (CCH) had opposed the same. A holistic view is to be taken by all stakeholders, namely Ministry of Health & Family Welfare, Ministry of AYUSH, CCH, CCIM, MCI and representative associations of practitioners of different discipline concerned as to whether or not to allow cross-pathy, perhaps to a limited extent. The course run at Hyderabad in collaboration with MF (Hom), UK cannot be considered to be eligible for recognition under Schedule III of the HCC Act as it is a course run in India, wherein MBBS graduates are trained in homoeopathy and hence tantamount to cross-pathy. This course at Hyderabad is without any consent or intimation to CCH as regards its details and cannot be recognized otherwise also till a consensus emerges on the issue of allowing cross-pathy in India.

Regarding, recognition of MF (Hom), UK it is a degree which is not in consonance of section 14 of HCC Act 1973, which stipulates mutual recognition of degrees, as UK does not recognize the degrees of homoeopathy regulated by CCH (BHMS & MD (Hom)). It has been historically recognized in India from the time the HCC Act came into being, perhaps because well known exponents and leading lights of Homoeopathy at that time were having that degree. Time has perhaps come to resolve this dichotomy with Ministry of AYUSH forcefully taking up mutual recognition of degrees of CCH & MF (Hom), UK with UK authorities, failing which it can be dropped from Schedule III of HCC Act.

As it has been observed earlier that the Faculty of Homoeopathy has imparted training in Homoeopathy in Hyderabad, India without permission of statutory bodies like CCH, the council therefore, does not recognize such qualification granted on the basis of the training conducted in India by the Faculty of Homoeopathy. The Faculty of Homoeopathy may be accordingly advised not to conduct such training and examination in Homoeopathy in India.

Further, the Ministry may take up the matter with the UK Authority pertaining to reciprocity in mutual recognition of each other's degrees and if it is unsuccessful, we can turn down the recognition of MF (Hom.), UK by invoking the section 14 of HCC Act, 1973 and delete it from Schedule III.

The EC proposed that the Ministry of AYUSH may frame a response to the VVIP reference keeping in view the above facts and logic.

The Executive Committee directed the office to complete the actions on the decisions in these minutes immediately, keeping in view of urgency of the matters.

Meeting ended with the vote of thanks to the Chair.
