Agenda item No. 10

Letter dated 06.06.2018 of Dr. D. Samba Murthy, Inspector (on deputation) requesting for repatriation to parent department.

The Executive Committee considered the request of Dr. D. Samba Murthy, Inspector for his pre-mature repatriation and also heard him in person and decided to relieve him by 30.09.2019. In the meantime, the office may take action to recruit new incumbent to the post of Inspector on deputation basis, in a time bound manner.

Agenda item No. 11

Payment of food charges @ Rs. 900/- per day to Medical Inspectors/Visitors.

The Executive Committee discussed the matter threadbare but did not find any merit to re-open the TA/DA claims which have been settled prior to 22.04.2019.

Agenda item No. 12

Letter dated 12.06.2019 of Sh. Pramod Kumar Pathak, Additional Secretary Ministry of AYUSH regarding Minutes of Meeting held on 09.01.2019 under the Chairmanship of Secretary (AYUSH).

The Executive Committee discussed the matter threadbare and felt that many technological initiatives such as AGBAS remains stuck due to judicial pronouncement by the Supreme Court regarding areas where use of Aadhar can be made mandatory. Similarly, implementation of Teacher's Code is still under process. Since, the term of reference of the committee will be famed taking into consideration technological advancement & other legal provisions; it would be advisable to defer the matter for time being.

Agenda Item No.13.1

Letter dated 02.05.2019 of Ministry of AYUSH regarding Reservation for Economically Weaker Section (EWSs) for admission in Central Educational Institutions.

The Executive Committee discussed the matter and opined that Ministry of AYUSH, may take appropriate decision at its own level and if Ministry finds it suitable to implement EWS in the Central/National Institutes, the Central Council will have no objection.

Agenda Item No.13.2

Recommendation of J.R. Kissan Homoeopathic Medical College, Rohtak for 2019-2020.

The Executive Committee in its meeting held on 05.04.2019 while considering the inspection report of J.R. Kissan Homoeopathic Medical College, Rohtak for 2019-2020, decided as under:

"Recommended for allowing admission in I-BHMS Course for the session 2019-20 with the intake capacity of 50 in existing UG (BHMS) course.

Recommended also for allowing admission in M.D.(Hom) Course in the subjects of Materia Medica, Repertory, Organon, Practice of Medicine, Pharmacy and Paediatrics with 05 seats in each subject and additional admission of 40 seats in existing UG course in compliance to order dated 08.01.2019 of Hon'ble High Court of Punjab & Haryana at Chandigarh."

The Committee noted that the additional 40 UG seats were recommended inadvertently in place of 50 additional UG seats and asked the office to send corrigendum to Ministry of AYUSH in this regard, immediately.

Agenda Item No.13.3

Mail of Principal Dhanwantri Homoeopathic Medical College regarding permission for 75 UG seats instead of 50 seats.

The Executive Committee considered the matter and asked the office to place it in the next meeting with all related facts.

The Executive Committee directed the office to complete the actions on the decisions in these minutes immediately, keeping in view of urgency of the matters.
