## Agenda item No. 1

Confirmation of the Minutes of the $28^{\text {th }}$ meeting of the Executive Committee of Board of Governors held on 19.06.2019 at New Delhi.

The Executive Committee confirmed the Minutes of its $28^{\text {th }}$ meeting held on 19.06.2019 at New Delhi as circulated.

## Agenda item No. 2

Action taken Report on the minutes of the 28th meeting of Executive Committee of Board of Governors held on 19.06.2019 at New Delhi.

The Executive Committee noted the Action taken by the office of the Council on the Minutes of the $28^{\text {th }}$ meeting of Executive Committee of Board of Governors of Central Council of Homoeopathy held on 19.06.2019 at New Delhi.

## Agenda item No. 3

Waive off the outstanding inspection fee $\&$ Penalty of Mirganj Homoeopathic Medical College, Bihar and Nehru Homoeopathic Medical College, Delhi.

The Executive Committee considered the matter and asked the office to request the Ministry of AYUSH for enforcement of provisions of section 19 of HCC Act (if not acted earlier), in the case of Mirganj Homoeopathic Medical College, Bihar and similar other colleges which are not functioning now, and thereafter, place the facts before Executive Committee.

So far as Nehru Homoeopathic Medical College is concerned, the matter may again be placed in the next meeting along with the copies of commission letters (if any issued for visit in 2002) and report of inspection/visit.

## Agenda item No. 4

Letter dated 16.06.2019 of Vice-Chancellor, Babasaheb Bhimrao Ambedkar Bihar University, requested to relax the sub Regulation 4A under the provision of 14(iii) of B.H.M.S. Regulation 1983 (amended upto March 2016).

The Executive Committee considered the letter dated 16.06.2019 of Vice-Chancellor, Babasaheb Bhimrao Ambedkar Bihar University for relaxation in the provisions of sub regulation 4A under regulations 14(iii) of B.H.M.S. Regulations, 1983 (as amended up to March, 2016) and expressed its displeasure for non compliance of said regulations by the University. Further, it was also expected from the authorities of the University to treat all the colleges at par so far as conduct of examination for the year 2015-16 and 2016-17 is concerned but leaving aside the principle of natural justice, the University arbitrarily conducted the examination of selected colleges only, which gives rise to cause of concern as regards motives.

Moreover it is not known, how the University regulated studies and examinations, in promoting the students from $1^{\text {st }} \mathrm{BHMS}$ to $2^{\text {nd }} \mathrm{BHMS}, 3^{\text {rd }} \mathrm{BHMS}$ or next batch without conducting examination till date, and whether students of all three years will be put to examinations in one go or the University will conduct examination one after another delaying the course duration. The effect of all this on teaching can be well imagined as well as the likely damage to the society at large after graduation of the students involved. This is a very sorry state of affairs. BBRA, Bihar University, Bihar should ensure the paramount interest of the students and the society and should not deal with such issues in routine manner.

To avoid any further loss of the students due to wrong action on the part of University, the Executive Committee agreed to allow one time relaxation with the condition that such types of lapses will not be repeated by the University in future. The Executive Committee also decided to communicate its above views to the office of the Chancellor of the University i.e. Hon'ble Governor of Bihar.

## Agenda item No. 5

Letter dated 30.05.2019 of Vice-Chancellor, Kerala University of Health Sciences, Thrissur regarding clarifications with respect to the demands from students with various incapacities and impairments (differently abled) for granting technical aids/supports

The Executive Committee discussed the matter and asked the office to seek clarification of MCI and UGC as well as Ministry of HRD in this regard. The EC further directed the office to look for any direction (if available) of Ministry of HRD in similar matter for other courses and place the matter again before committee with all information.

## Agenda Item No. 6

Mail of Principal, Dhanwantri Homoeopathic Medical College regarding permission for 75 UG seats instead of $\mathbf{5 0}$ seats.

The Executive Committee discussed the matter regarding intake capacity of Dhanwantri Homoeopathic Medical College, Maharashtra and agreed the intake capacity of college as 75 as per available records. Further the EC decided for re-inspection of the college as it was not inspected for 75 UG seats.

## Agenda Item No.7.1

Letter dated 25.06.2019 received on 26.06.2019, of Principal, Anushree Homoeopathic Medical College, Jabalpur, Madhya Pradesh, regarding permission for admission for 100 UG seats instead of 60 seats.

The Executive Committee discussed the letter dated 25.06.2019 of the Principal of the college and inspection report of Anushree Homoeopathic Medical College, Jabalpur, Madhya Pradesh regarding permission for the session 2019-20 and decided to recommend for admission of 100 UG seats instead of 60 seats. The EC asked the office to send corrigendum to Ministry of AYUSH in this regard, immediately.

## Agenda Item No.7.2

Application dated 04.05.2019 of the President, Sri Sai Nath PG Institute of Homoeopathy and Research Centre, Prayagraj, (UP) for grant of approval to start BHMS course at Sri NAth PG Institute of Homoeopathy and Research Centre, Allahabad with intake capacity of 100 seats from the Academic session 2019-20 in compliance of order dated 23.04.2019 of the Hon'ble High Court of Judicature at Allahabad.

The Executive Committee considered the application of President, Sri Sai Nath PG Institute of Homoeopathy and Research Centre, Prayagraj, (UP) and decided to process the application as per relevant regulations.

## Agenda Item No.7.3

Letter dated 24.06.2019 of Ministry of AYUSH regarding Implementation of reservation of $10 \%$ seats for the Economically Weaker Section (EWS) candidates by enhancing Undergraduate seats in the existing Govt./Govt. aided Homoeopathic Medical Colleges u/s 12A of the HCC Act, 1973 for the academic year 2019-20.

The Executive Committee considered the letter dated 24.06.2019 of Ministry of AYUSH regarding Implementation of reservation of $10 \%$ seats for the Economically Weaker Section (EWS) candidates in pursuance to the provisions of the Constitutional Amendment (one Hundred and Third Amendment) Act, 2019 dated 12.01.2019 by enhancing Undergraduate seats in the existing

Govt./Govt. aided Homoeopathic Medical Colleges u/s 12A of the HCC Act, 1973 for the academic year 2019-20. The Executive Committee noted the letter dated 24.06.2019, guideline \& format of this Council which had been sent to all State Govt. and Govt./Govt. aided Homoeopathic Medical College requesting their proposal in this regard.

The EC considered all the proposals received from the State Govt. and Govt./Govt. aided Homoeopathic Medical Colleges and agreed to recommend the same to the Ministry and further directed to recommend to the Ministry all proposals for $25 \%$ enhancement of permitted seats as and when received by this Council subsequently and place the same before EC for post facto information.

The Executive Committee directed the office to complete the actions on the decisions in these minutes immediately, keeping in view of urgency of the matters.
