## Amendment in Standing Orders of the Council.

Executive Committee considered the matter of amendment in Standing Orders and also noted the provisions in Standing Orders of CCIM and agreed with the office proposal with following changes:-
S.O. No. 6(a) The provisions of CCIM Standing Order No.6(a) may be adopted.
S.O. No. 7. Not required in view of provisions of S.O. No.9, thus needs to be deleted.
S.O. No.11. The line "mutatis-mutandis and as amended from time to time" be inserted in the proposed amendments.
S.O. No.22. No need to delete, it may be retained.
S.O. No.30. Last line "He shall also handle the work related to R.F.D." may be deleted.
S.O. No.33(a). The provisions of CCIM Standing Order No.52(1) may be adopted.
S.O. No.34. The provisions of CCIM Standing Order No. 54 may be adopted.
S.O. No.39. The provisions of CCIM Standing Order No. 62 may be adopted but the words "Ministry of Health \& Family Welfare" be replaced by "Ministry of AYUSH".
S.O. No.40. The provisions of CCIM Standing Order No. 58 may be adopted but the words "Ministry of Health \& Family Welfare" be replaced by "Ministry of AYUSH".

After making required changes with renumbering, the matter may be placed before BoG for approval.

## Agenda Item No. 4

Payment of Sitting Fee to the Chairperson and members of Board of Governors of Central Council of Homoeopathy as and when they attend the meeting/programme conveyed by M/o AYUSH or by other Government/Parliamentary authorities.
