“It is resolved after prolonged discussions that the matter concerning election of members in terms of Section 3(1) of HCC Act, 1973 and conflicting communications of Central Govt. through Ministry of AYUSH and judgements being received from Hon’ble High Courts it is imperative to have clear legal remedy/order by filing a case before Hon’ble High Court Delhi to settle the matter once for all.”

**Letter No. 4(1)/2017-H&F.W. NITI Aayog dated 30.1.2017 regarding Homoeopathy Central Council Act.**

The Central Council discussed the matter at length wherein many members like Dr. S. M. Desarda, Dr. Rajesh Sharma, Dr. S. M. Singh, Dr. Sampath Rao, Dr. L. K. Nanda, Dr. R. K. Manchanda, Dr. Rudresh, Dr. Dongre, Dr. Kundu, Dr. Rajat Chattopadhyay, Vice-President Dr. Arun Bhasme and President Dr. Ramjee Singh participated. It was unanimously decided that the Medical Council of India and CCIM may also be consulted for their response to NITI Aayog in the proposal of NITI Aayog for constitution of a National Medical Commission and Nation Commission on Indian Medicines and in a time bound manner this Council may also submit a detailed response to NITI Aayog in respect of proposed National Commission on Homoeopathy for which President is authorized.

**Agenda Item No. 57.5**

**Ministry's letter No.R.13040/08/2017-HD(Tech.) dated 01.02.2017 regarding inspections.**

The Central Council debated the matter wherein members like Dr. Sampath Rao, Dr. S. M. Singh, Dr. Pinakin Trivedi, Dr.S. M. Desarda, Dr. Dongre, Dr. Tejinder Pal, Dr. Girish Patel, Dr. Mrs. Desarda, Dr. Bhardwaj, President Dr. Ramjee Singh etc. participated wherein the points were raised as under :-

- Whether Ministry of AYUSH, Govt. of India has the authority (in terms of HCC Act) to give permission every year to those Homoeopathic Colleges which were in existence prior of notification of amendments in HCC Act (on 09.12.2002) for admission of students ;
- whether Ministry of AYUSH, Govt. of India has any right to conduct inspection of colleges in terms of HCC Act, 1973;
- whether Ministry of AYUSH, Govt. of India has any right to issue directives to CCH for deciding the procedure of inspections to be undertaken by the Central Council

The President informed about his interaction with the authorities of CCIM in the matter who have decided to inspect the colleges as per provisions of IMCC Act and Regulations made thereunder instead of agreeing with similar directives issued by the Ministry to CCIM. The Central Council also decided to follow the line of action being decided by CCIM. If need be the President may also consult the Council's advocate in the matter.

The Central Council further decided that the office of CCH may reflect the data, the variations in the decisions taken by the Ministry in respect of all colleges approved or disapproved vis-a-vis the recommendations sent by the Central Council and / or its Executive Committee (during 2016-17), and about list of colleges allowed (even as interim relief) by the Hon'ble Courts for admission of students for 2016-17.

The Central Council discussed the matter at length in which the members like Dr. A. L. Patil, Dr. S. M. Desarda, Dr. Pankaj Sharma, Dr. Ayesha Ali, Dr. Konkani, Dr. Debnath, Dr. Sampath Rao, Dr. Tejinder Pal Singh, Dr. Ravi Bhosale, Dr. Aushutosh Bhardwaj, Dr. Rajat, Dr. Prashobh, Dr. Rakesh, Vice-President Dr. Arun Bhasme and President. Dr. Ramjee Singh participated.

The Central Council decided that the Education Committee may meet within a period of one month to look into the needs of amendment in Homoeopathy (Degree Course) Regulations for providing the provisions of National Eligibility cum Entrance Test (NEET). The Central Council also decided to request the Ministry of AYUSH, Govt. of India to allow admission procedure for 2017-18 in BHMS Course as prescribed at present in Homoeopathy (Degree Course) Regulations (as amended till date), for the reason that Central Govt. has so far not authorized any agency to undertake NEET for admissions in BHMS Course during 2017-18 and further for the reason that the list of Homoeopathic Medical Colleges to be allowed admissions for 2017-18 does not exist. The Central Council considered letter dated 17.03.2017 of Association of Management of Homoeopathic Medical College of Maharashtra. It further decided to request the Ministry of AYUSH, Govt. of India to allow management quota in admission for 2017-18 as per policy of concerned State Govts./ UT Administrations as was exercised for the previous years.

The Central Council considered the matter and it agreed with the Central Govt. that the colleges need to pay salaries of all staff members including teaching, hospital and others through direct transfer into their bank accounts directly and

same may be verified during inspections by Inspectors/Visitors. However, regarding stand of the Central Govt. to make it compulsory for the colleges to ensure that the teachers appointed on the basis of diploma/degree qualification are enrolled in Post Graduate Courses within three years, is neither in consonance with the provisions of HCC (MSR) Regulations, 2013 nor practical as pointed out at point 6 in DO letter dated 15<sup>th</sup> February, 2017 by the Vice-President to the Joint Secretary (in Ministry).

The Central Council discussed the matter in depth wherein members like Dr. Pankaj Sharma, Dr. Mohd. Zakharia, Dr. Pawan Dongre, Dr. Rakesh Singh, Dr. Rajat Chattopadhyay and President Dr. Ramjee Singh etc. shared their views and the Council decided that the proposal of amendments in HCC(MSR) Regulation so far agreed by Ministry may be allowed till any reference is received there to from Ministry as the same has been displayed on Ministry's website for public opinion/ views. Further, the Council did not agree to put any pre-condition or requirement of NACC accreditation of Homoeopathic Medical Colleges and NABH accreditation of Hospitals attached to the colleges and it may be left open for the colleges to get the said accreditations done if they want to.

However the Central Council approved the following amendments to said Regulations :-

1. In regulation 3, sub-regulation 1 may be retained and remaining sub-regulations from (2) to (9) shall be deleted as has been proposed earlier.
2. Sub-regulation (2) of regulation 9 shall be omitted.
3. Sub-regulation (3) and (4) of regulation 7, and table under Schedule III in respect of Hospital equipment, along with its footnote shall be put at one place (as enclosed).
4. Below the table under Schedule-IV in respect of Minimum Teaching staff for Degree Course, in N.B. (3), the following shall be inserted :-

‘Where the full time staff is available in all three cadres, then there shall be no requirement for appointment of Guest faculty in the concerned Department(s).’

5. In sub-regulation (3) of regulation 9, the words ‘sixty five years’ shall be substituted as ‘Seventy five years’.
6. In Schedule I A, at S. No. 3(vii) the sign and words ‘/Duty room/ shall be omitted.
7. In Schedule I B-
  - (a) S. No. 2 shall be substituted as under –  
‘Lecture Halls – there shall be 5 Lecture Halls with capacity to accommodate 60/100 students with Audio-Visual Aids.’
  - (b) At S. No. 5, the words and digits ‘of at least 40 Sq.M. each’ shall be omitted.
