

NEW REGULATIONS ENFORCED FOR OPENING OF NEW COLLEGE, HIGHER COURSES OF STUDY AND INCREASE OF SEATS


entral Council of Homoeopathy in exercise of the powers conferred by Section 33 and Section 12A of the Homoeopathy Central Council Act, 1973 (59 of 1973), with the previous sanction of the Central Government, enforced new Regulations namely, Establishment of New Medical College (opening of New or Higher Course of Study or Training and Increase of Admission Capacity by the Medical College) Regulations,



2011 by notifying them in the Gazette of India on 14th October, 2011 (corrigendum published on 21st February 2012). The said Regulations came into force on the date of publication in the Official Gazette.

Any person intending to establish a new Homoeopathic Medical College or any existing Homoeopathic Medical College intending to open a new or higher course of study or training or intending to increase admission capacity in any course of study or training in Homoeopathy is required to follow the procedure and criteria mentioned in the said Regulations and to submit a Scheme to the Central Government along with an application and fees as prescribed.

AMENDED POST GRADUATE DEGREE COURSE REGULATIONS NOTIFIED



Central Council of Homoeopathy in exercise of the powers conferred by clauses (i), (j) and (k) of Section 33 and sub-section (1) of Section 20 of the Homoeopathy Central Council Act, 1973 (59 of 1973), with the previous sanction of the Central Government, notified Homoeopathy (Post Graduate Degree Course) M.D. (Hom) Amendment Regulations, 2012 by publishing them in the Gazette of India on 5th March, 2012.

MEETINGS OF CCH AND ITS COMMITTEE

DIRECT REGISTRATION BY C.C.H.

During the last quarter of 2011-12, the Council received 60 applications for direct registration from the homoeopathic practitioners holding recognized medical qualification, and registration with the State Boards/Councils, and it has issued Direct Registration Certificates to 88 applicants.

INSPECTION OF HOMOEOPATHIC MEDICAL COLLEGES

The Central Council of Homoeopathy inspected 15 Homoeopathic Medical Colleges and one examination centre of BHMS examination of a University during the period under report to monitor the extent the minimum required facilities and standards of education are met by them.

FORMER PRESIDENT OF CCH PADMASHRI DR. JUGAL KISHORE IS NO MORE



The Indian Homoeopathic Legend and former President of Central Council of Homoeopathy Dr. Jugal Kishore, has passed away in the morning of 24th January, 2012. Dr. Jugal Kishore was instrumental in establishing homeopathy in India. His contributions in education, research, clinical practice, policy making and manufacturing of quality medicines were immense and incomparable. It is a great loss to homeopathy.

He was the Vice-President of this Council from 6th August 1974 to 5th August, 1976 and President from 6th August, 1976 to 4th February, 1991.

Dr. Jugal Kishore successfully obtained the prestigious D.M.S. qualification from the motherland of Homoeopathy in India under General Council and State Faculty of Homoeopathic Medicine, West Bengal and later on the Council of Homoeopathic Medicine, West Bengal conferred him the Honorary Degree M.D. (Hom).

Dr. Jugal Kishore never intended to be a physician - he had actually appeared for ICS exams after topping the University in his B.Sc. exams. But, call it a quirk of fate; he fell so ill that he was bedridden for almost a year. During this period he stumbled across some books on Homoeopathy. While browsing through these books he happened to read a remedy which he thought might help him. He experimented upon himself for a year & to his delight found himself responding positively to it. Therefore he developed such immense faith in homoeopathy that against his family & friends' wishes he decided to study Homoeopathy. He was convinced that this was his CALLING & DESTINY & hence he enrolled himself at The Calcutta Homoeopathic College & the rest, as they say, is History.

Dr. Jugal Kishore started his Homoeopathic practice in June, 1945 from a modest clinic at 12/40 Connaught Circus. Soon a need was felt for better premises & the clinic was moved to Himalaya house at Kasturba Gandhi Marg, New Delhi & then, in the year 1971 to Kanchanjunga Building, Barakhamba Road in the capital of India. For the last almost 30 yrs. he was practicing at 86, Golf Links, which also happened to be his residence.

Dr. Jugal Kishore has authored a number of books some of which are:

- Kishore Card Repertory
- Integrated Repertory Mind and Generalities
- Evolution of Repertories

He also discovered & proved new Homoeopathic remedies & was constantly endeavoring to improve upon the present Homoeopathic Materia Medicas & Repertories. Government of India in 2012 awarded posthumously prestigious 'Padma Shri' to him.

President, Vice-President, Members and officials of the CCH stood in silence for one minute during the General Body meeting of the Council in March 2012 to pay homage to the departed soul.
