entral Council of Homoeopathy conducted a workshop on "Quality of Education in Homoeopathy" for its members on 30th & 31st October, 2009 at New Delhi. The workshop was inaugurated by Smt. S. Jalaja, Secretary to Govt. of India, Ministry of Health and Family Welfare, Department of AYUSH.



WORKSHOP ON PHYSIOLOGY

Central Council of Homoeopathy conducted a workshop on Physiology (including Biochemistry) for the teachers of Homoeopathic Institute of Medical Sciences, Nagpur, Dr. Raj Kapur, Professor, Vardhman Mahavir Medical College & Hospital, New Delhi, Dr. Kalpana Luthra,

Medical Colleges on 21st & 22nd December, 2009 at New Delhi. The workshop was inaugurated by Dr. Ramjee Singh, President of the Council. The objective of the workshop was to promote skills and techniques in teaching of Physiology (including Biochemistry).

The resource persons were namely, Dr. S.S. Kochhar, Professor, Gondia Homoeopathic Medical College, Gondia, Dr. Suresh Chari (Ex-Professor, Nagpur Medical College), presently Director, NKP Salve Associate Professor, AIIMS, New Delhi, Dr. Sanjay Ghosh Mandal, Professor, NIH, Kolkata and Dr. Lalit Baran Chakravorty, Professor, Burdwan Homoeopathic Medical College and Hospital, Burdwan.

The topics covered by the speakers/ resource persons have been as under-

 Physiology of Nervous System & importance of teaching applied aspects for interpretation of reflexes.

- 2) Teaching Biochemistry as Today's speciality.
- Demonstration Techniques for giving practical knowledge for Physiology & Biochemistry.
- Integration of teachings of Anatomy, Physiology & Biochemistry.
- Endocrinology importance of applied knowledge vis-a-vis life style diseases.
- PAIN-applied Physiology-Teaching Techniques.

Following recommendations on the subject have emerged in the said Workshop:-

- (a) The syllabus of Biochemistry needs to be explored further;
- (b) Separate part(s) in each question paper(s) of Physiology be made essential;
- (c) Separate Deptt. of Biochemistry be prescribed.
- (d) Problem based learning may be stressed.

38 Participants attended the workshop and they interacted and discussed with the resource persons.

INSPECTION OF HOMOEOPATHIC MEDICAL COLLEGES

The Central Council of Homoeopathy inspected 37 Homoeopathic Medical Colleges, and 8 centres of BHMS Examinations from October to December 2009, to assess the facilities and standards of education.

CENTRAL REGISTER OF HOMOEOPATHY

The Council has published Central Register of Homoeopathy in the Official Gazette in Jan.1993, Jan. 1996, April, 2003, Oct. 2004, May 2007, Nov. 2008 and August 2009 on the basis of State Registers of Homoeopathy which also include practitioners directly registered with C.C.H. Central Council of Homoeopathy has issued Direct Registration Certificates to 74 applicants (from April to December, 2009).

INCREASE OF INTAKE CAPACITY

The Executive Committee of the Central Council of Homoeopathy has recommended to the Central Government for an increase in admission capacity in B.H.M.S. course in the following colleges:

- 1. P.D. Jain Homoeopathic Medical College, Parbhani up to 50 students in Ist BHMS Degree Course.
- Sarada Krishna Homoeopathic Medical College, Kanyakumari

from 50 to 100 in Ist BHMS Degree Course.

RECOGNITION OF QUALIFICATIONS

The Executive Committee of the Central Council of Homoeopathy has recommended for recognition of following qualifications to the Central Government:-

- 1. BHMS Degree awarded by IASE University, Sardarshar, Dist. Churu for the year 2009 only.
- 2. M.D. (Hom) awarded by Baba Farid University of Health Sciences, Faridkot from November, 2005 onwards in respect of Materia Medica, Organon of Medicine and Homoeopathic Philosophy and Repertory.
- 3. BHMS Direct & Graded Degrees of Bihar University from 1986 till July, 1991; and from August, 1991 onwards in respect of Bhim Rao Ambedkar Bihar University, Muzaffarpur.
- 4. M.D. (Hom) awarded by Bharati Vidyapeeth University, Pune in the subjects of Homoeopathic Pharmacy, Homoeopathic Repertory, Practice of Medicine & Homoeopathic Materia Medica from October, 2009.

 BHMS Degree qualification awarded by Pt. Ravi Shankar Shukla University, Raipur beyond 2008 up to December, 2010.

- Neminath Homoeopathic Medical College & Hospital, and Research Centre, Etnadpur, Agra

for making admissions not exceeding 50 students.

OF STATE BOARDS/ COUNCILS OF HOMOEOPATHY

The Central Council conducted a workshop for the Registrars of different State Boards/Councils of Homoeopathy on "Amendment to Homoeopathy Central Council (Registration) Regulations 1982" on 14th December 2009 at New Delhi. The workshop was inaugurated by Dr. Arun N. Bhasme, Vice-President of the Council. The

matter of providing transfer of practitioners from one state to another was discussed. Registrars of State Boards of Uttar Pradesh, Jammu & Kashmir, Karnataka, Rajasthan, Delhi, Maharashtra, Meghalaya, Uttarakhand, Orissa, Goa, Gujarat, Haryana, Punjab, U.T. Chandigarh, Tamilnadu, Tripura, Andhra Pradesh, West Bengal, Madhya Pradesh and Kerala participated in the workshop. Members of Executive Committee and Registration Committee of CCH also participated in the discussions in the said workshop.

Dr. Lalit Verma, Registrar, CCH highlighted the difficulties being faced in gathering the required data from the State Registers. Dr. Markand Bhatt, Chairman, Registration Committee addressed the participants. Sh. H.D. Rikhadi, Asstt. Secretary (A.R.) proposed a vote of thanks.

The following recommendations were made in the workshop:-

- (a) CCH may make a uniform application format for applying for State Registration and also a format for maintaining State Register besides a format for issue of Registration Certificate by the State Boards/Councils, and circulate among all the State Boards;
- (b) the State Registers (updated) may be furnished every year to C.C.H. during the month of April without repeating the old entries;
- (c) the State Councils/
 Boards will indicate the date of completion of the course in respect of B.H.M.S. Degree by mentioning the date of completion of

compulsory internship training in the specified column or at-least in the Remark column of the State Registers;

- (d) all the State Boards/ Councils must appoint registered Homoeopathic Practitioners as Registrars on full time regular basis. However the Registrars representing Boards of U.T. Chandigarh, Punjab and Haryana did not agree to the proposal; State Councils must appoint registered Homoeopathic Practitioners as Registrars on full time regular basis. However the Registrars representing Boards of U.T. Chandigarh, Punjab and Haryana did not agree to the proposal;
- (e) State Boards/Councils will act promptly to respond to the letters of C.C.H. and vice versa;
- (f) Since no representatives from States of Bihar and Nagaland were present, it was decided that the Central Govt. and C.C.H.

both may again take up the matter with concerned authorities of these State Governments and State Boards to furnish the relevant information.

(g) Regarding uniformity in fees charged by State Councils and uniformity in State legislations, consensus could not be arrived at.

PRESIDENT (CCH) VISITED MAHARASHTRA UNIVERSITY OF HEALTH SCIENCES


